An individual who has been affiliated with a firm comprised of REALTOR® members forty (40) years or more, but who was ineligible for REALTOR® or REALTOR-ASSOCIATE® membership for any portion of that time on the basis of sex, national origin, marital status or other basis now prohibited by the Bylaws of the National Association shall be eligible for REALTOR® Emeritus status.

The requirement of one year of National service, as defined above shall be effective for persons qualifying for REALTOR® Emeritus status.
